# SPECIAL ISSUE G-CASE Elections

You will be sent information to vote electronically for your choices next week. Voting will take place the week of February 17<sup>th</sup> and will be closed on Friday, February 22, 2019. Winners will be announced at the *2019 G-CASE Spring Legal Forum* in Athens during the G-CASE Business Meeting on Tuesday, March 19, 2019. Please take a few minutes to study the biographies of each of our candidates. Each one will bring effective experience and strong leadership to our organization.

#### **Candidates for Vice President**

The position of <u>Vice President</u> shall be one of learning the total organization in order to move into the President position in two years. The Vice President will accede to the office of President-Elect in 2020 and then to President in 2021.



**Dr. Cassandra Allen Holifield** is a well-respected educational leader who works in the field of Special Education with an emphasis in Emotional Behavioral Disorders, Autism Spectrum Disorders, Learning Disabilities, mental health, and trauma. Dr. Holifield earned her doctorate degree (Ph.D.) from Georgia State University and she currently serves as the Director of North Metro Georgia GNETS. Prior to this job, Dr. Holifield served as the Director of Northwest GLRS,

Special Education and English Language Learning Product Manager for Western Governors University, the Emotional Behavioral Disorders Program Specialist for the GaDOE in which she played a pivotal role in bringing PBIS to the state of Georgia, then known as EBIS. Dr. Holifield was also a former EBD and Autism teacher for Atlanta Public Schools in which she piloted the first Autism class at Walter White Elementary for students previously served in more restrictive settings back into a regional program. Dr. Holifield has also had the honor of serving as a Special Education Ambassador to South Africa in 2005. She is a published author of an article and a book, "Using Self-Monitoring to Increase Attending to Task and Academic Accuracy in Children with Autism," and "The ABC's of Response to Intervention & Behavior Next Steps: A Practitioner's

Guide to Implementation." Dr. Holifield also serves as a part-time Special Education Contributing Faculty member of Walden University. Additionally, she is an active member of her sorority, the Rho Zeta Omega Chapter of Alpha Kappa Alpha Sorority Inc. Dr. Holifield has over 20 years of educational and behavioral experiences as a practitioner, researcher, leader, and an agent of social change positively impacting the community.
